- Except, as provided by law, where Mechanical work has been started prior to obtaining a permit, the regular fee therefor shall be doubled.
- Mechanical permit shall expire if work is not commenced within 120 days or if work is abandoned for 120 days.
- It is the responsibility of permittee to call for inspections – Phone 515-961-9430.
- Permits are non-transferable – all work shall be performed by permittee or his employee.
- No mechanical work shall be concealed or covered until approved by the inspector. Work that is not tagged with an approval shall be considered unapproved.
ALL WORK MUST BE INSPECTED.
- The permittee is assumed to be knowledgeable of the Mechanical Code – Any questions should be resolved prior to installation.

D. For the installation or relocation of each boiler -		\$6.00 plus \$1.75 per 100,000 BTU/H input or fraction thereof.	
E. For the installation or relocation of each comfort cooling system or refrigeration unit -		\$3.75	
F. For each air handling unit, including ducts -		\$3.00	
G. For each single duct ventilation fan -		\$5.00	
H. For each evaporation cooler (non-portable), hood (including ducts), or separative ventilation system		\$3.00 each \$1.75 each	
I. Gas Piping: First four outlets – All outlets over four –		\$5.00	
J. For each appliance or piece of equipment regulated by this code but not classed in other appliance categories, or for which no other fee is listed in this code –		\$4.50
